

12th STREET WORKSHOP ONLINE BUSINESS MEETING
DECEMBER 9, 2025

The meeting was opened at 4:30 pm ET with the Serenity Prayer

From 21-32 members were present

REPORTS:

SECRETARY (Addie): Minutes from November meeting were read and accepted.

TREASURER (Bruce): The prudent reserve is currently \$200. Bruce reviewed last months activity and report: the Venmo account had been closed on November 5th, 2025, and at that time contributions of \$487 to Intergroup, and \$487 to AA General Services, respectively, were made. Concern was expressed that the current prudent reserve may not be sufficient for possible future activities, such as funding books for new-comers. Report accepted.

At this point the meeting was disrupted by a member with host tools, who attempted to take this meeting, as host. That was dealt with, and the meeting resumed.

GSR: Kerry was not present, but it was noted that he had signed up for an on-line orientation workshop to be held in January. Report accepted.

SPONSORSHIP COORDINATOR; (Rizz): Not much activity, 1 or 2 calls, a few referrals. He continues to update the list. Report accepted

OLD BUSINESS:

1. Addie gave an update about the Website. The Website and Domain are now ours, and now we need to understand the steps to edit/update it. The WIX first year website fee is currently being paid as a contribution from a member, which is allowed for Group Conscience approved expenses. The domain is free for the first year. Next year the Website is projected to cost \$240, and the domain \$13/year.

2. A vote to keep the current Logo for the 12th street Online Workshop was accepted.

NEW BUSINESS:

1. Motion made by Danny: that "Meeting Hosts have autonomy to allow double dipping at Topic meetings, at the host's discretion". The motion passed.

How much autonomy should meeting host have, in general, was discussed.

2. Motion made by Bruce: That the script be modified to include wordage that the 12th Street Workshop Online is not currently accepting contributions and that the website, NYINTERGROUP.ORG, be suggested for members who wish to contribute to AA. The Motion to add that "we are not accepting contributions at this time, and that members who wish to contribute be directed to NYINTERGROUP.ORG" was accepted.

Members' comments/suggestions: Include posting links to free literature: Everything AA, where the Big Book etc can be accessed as a PDF or audio. Increasing our prudent reserve was suggested, specifically to be able to mail out literature. It was suggested that this may require a Group Conscience and formation of a Trusted Service position to carry that out.

It was suggested that Hosts follow the script, and avoid individual deviations.

Tabled were Motions to extend the speaker time by 5 minutes, to establish a meeting for Meeting Hosts, and to revise the script.
